2. Penalty clause to be imposed @ 0.25% to 2.5% per month and part thereof of the total cost, if the work is not completed within the schedule time or mutual extended period.
3. The construction of the proposed work may be carried out as per the specification/measurement laid down in the approved estimate. Copy of the same are enclosed herewith.
4. Initial payment as mobilization advance i.e. 33% of the estimated cost for Rs.5, 37,240/- (Rupees five lakhs thirty seven thousand two hundred and forty) only shall be release immediately on receipt of the acceptance of the work awarded from your end.

5. Part payment, if any, shall be made on production of the progress report statement of the work.
6. Full and final payment shall be made after handing over of the project (subject to fulfillment of all codal formalities such as inspection-cum-completion report, submission of required bills, MB etc).
